# Section 3 - Hazards Identification

#### **EMERGENCY OVERVIEW**

Appearance: clear pale yellow to red brown liquid. Flash Point: 85 deg C.

Warning! Causes eye, skin, and respiratory tract irritation. Harmful if swallowed. Combustible liquid and vapor. Impairs the oxygen carrying capacity of the blood. May be harmful if absorbed through skin or if inhaled. May cause methemoglobinemia.

Target Organs:Blood, respiratory system, eyes, skin.

## **Potential Health Effects**

**Eye: Causes eye irritation.** 

Skin: Causes skin irritation. May be harmful if absorbed through the skin. Ingestion: Harmful if swallowed. May cause irritation of the digestive tract.

Methemoglobinemia is characterized by dizziness, drowsiness, headache, shortness of breath, cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood), rapid heart rate and chocolate-brown colored blood. Overexposure may cause methemoglobinemia.

Inhalation: Causes respiratory tract irritation. May be harmful if inhaled. Chronic: Absorption into the body leads to the formation of methemoglobin which in sufficient concentrations causes cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood).

# Section 4 - First Aid Measures

**Eyes:** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

**Skin:** Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

**Ingestion:** If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

**Inhalation:** Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

**Notes to Physician:** Treat symptomatically and supportively.

**Antidote:** Methylene blue, alone or in combination with oxygen is indicated as a treatment in nitrite induced methemoglobinemia.

# Section 5 - Fire Fighting Measures

**General Information:** As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Use water spray to keep fire-exposed containers cool. Water may be ineffective.
